

RESOLUTION No. 2018-04
ESTABLISHING THE PREVAILING RATE OF WAGES FOR LABORERS, MECHANICS AND
OTHER WORKERS IN THE LOCALITY OF THE VILLAGE OF MORTON GROVE

WHEREAS, the State of Illinois has enacted “An Act regulating wages of laborers, mechanics and other workers employed in any public works by the State, County, City or any public body or any political subdivision or by anyone under contract for public works,” approved June 26, 1941, as amended, being 820 Illinois Compiled Statutes 130/0.01 et seq., as amended; and

WHEREAS, the aforesaid Act requires that the MORTON GROVE PUBLIC LIBRARY, a body politic, of the Village of Morton Grove, County of Cook and State of Illinois, investigate and ascertain the prevailing rate of wages as defined in said Act for laborers, mechanics and other workers in the locality of said MORTON GROVE PUBLIC LIBRARY, employed in performing construction of public works, for said MORTON GROVE PUBLIC LIBRARY.

NOW THEREFORE, BE IT RESOLVED by the Board of Trustees of the Morton Grove Public Library, Cook County, Illinois, as follows:

SECTION 1: To the extent and as required by “An Act regulating wages of laborers, mechanics and other workers employed in any public works by State, County, City or any public body or any political subdivision or by anyone under contract for public works,” approved June 26, 1941, as amended, the general prevailing rate of wages in this locality for laborers, mechanics and other workers engaged in construction of public works coming under the jurisdiction of the MORTON GROVE PUBLIC LIBRARY is hereby ascertained to be the same as the prevailing rate of wages for construction work in the Cook County and surrounding area as determined by the Department of Labor of the State of Illinois as of September 25, 2017 and April 11, 2018, a copy of that determination being attached hereto and incorporated herein by reference. The definition of any terms appearing in this Resolution which are also used in the aforesaid Act shall be the same as said in the Act.

SECTION 2: Nothing herein contained shall be construed to apply said general prevailing rate of wages as herein ascertained to any work or employment except public works construction of the MORTON GROVE PUBLIC LIBRARY to the extent required by the aforesaid Act.

SECTION 3: The MORTON GROVE PUBLIC LIBRARY Secretary shall publicly post or keep available for inspection by any interested party in the main office of the MORTON GROVE PUBLIC LIBRARY the determinations of such prevailing rate of wage.

SECTION 4: The MORTON GROVE PUBLIC LIBRARY Secretary shall mail a copy of this determination to any employer, and to any association of employers and to any person or association of employees who have filed their names and addresses, requesting copies of any determination stating the particular rates and the particular class of workers whose wages will be affected by such rates.

SECTION 5: The MORTON GROVE PUBLIC LIBRARY Secretary shall promptly file a certified copy of this Resolution with the Department of Labor of the State of Illinois.

SECTION 6: The MORTON GROVE PUBLIC LIBRARY Secretary shall cause to be published in a newspaper of general circulation within the area a copy of this resolution, and such publication shall constitute notice that the determination is effective and that this is the determination of this public body.
